The Ahmedabad District Co-Operative bank Ltd. endeavours to safeguard and ensure the security of the information provided by the Customer. The Ahmedabad District Co-Operative bank Ltd. uses 128-bit encryption, for the transmission of the information, which is currently the permitted maximum level of encryption in India. The Customer would be required to cooperate with the The Ahmedabad District Co-Operative bank Ltd. in order to ensure the security of the information, and it is recommended that the Customers use 128-Bit encryption and must necessarily choose their passwords carefully such that no unauthorized access is made by a third party.
